NOTICE OF AN EXTRA ORDINARY GENERAL MEETING (EGM)

Notice is hereby given that an Extra-ordinary General Meeting (EGM) of the Gulshan Central Masjid & Iddgah Society will be held on Saturday the 26th April 2025 at 11.00 A.M. in the Registered Office of the Masjid Society. Hon'ble President of Gulshan Central Masjid & Iddgah Society, former Ambassador and Foreign Secretary Janab Mufleh R. Osmany will preside over the meeting In-Sha-Allah to approve with or without modification of the following amendments to the Rules of the Gulshan Central Masjid & Iddgash Society:

Proposal for Amendment of Rules:

1. Replace the following in Memorandum of Association and Articles of Association Definitions

03. (ii):

“GCMIS” shall mean “Gulshan Central Masjid & Iddgah Society” instead of “The Masjid Society” in all part of the Memorandum of Association and Articles of Association of Gulshan Central Masjid & Iddgah Society.

2. Add the following in Articles of Association Definitions 03. (iii):

“Gulshan” shall mean “Gulshan Model Town, Dhaka, Bangladesh” and renumbering the section 3. Accordingly upto xvii.”

3. Replace the following in Article of Association Definitions 05. Membership: b.:

“All devout practicing Muslims, permanently those Self/ Spouse/ Parents and Childrens having space and living in Gulshan Model Town area, Dhaka. Supported by relevant title deeds, holding Tax, Electric bill and NID will be eligible for membership, subject to provisions of this Memorandum and Articles of Association. Members who have previously been elected as life members but are not residents of Gulshan Model Town will not be eligibile to become the official of the Management Committee.”

Instead of

“All devout practicing Muslims, generally those living in Gulshan Model Town area, will be eligible for membership, subject to provisions of this Memorandum and Articles of Association”.

4. Replace the following in Article 06. PATRON:

*“The Managing Committee may recognize and honour a Devout Practicing Muslim who is not member as per above Article 5 and confer the title of “PATRON” for exceptional Fee Sabilillah service (**donation**) in the advancement of the Aims and Objectives of the Masjid Society. An*

Advisory pannel will constitute from the life memebes. The number of Pannel and TOR will be determined by the Mangement committee from time to time. ”

instead of

The Managing Committee may recognize and honour a Devout Practicing Muslim who is not a Member (Art. 5 above) and confer the title of “PATRON” for exceptional Fee Sabilillah service in the advancement of the Aims and Objectives of the Masjid Society”.

5. **Replace the following in Article 14.COMPOSITION AND TENURE OF THE MANAGING COMMITTEE: (i):**

*“The Managing Committee shall consist of the following fifty one (51) elected **and** co-opted Members”*

instead of

*“The Managing Committee shall consist of the following fifty one (51) elected **or** co-opted members”*

6. **Add the following in Article 26 f:**

The finance sub-committee will directly supervise the matter related to purchase & sales by creating a sub-section called Purchase & Sales Rules and Regulations which will be made by the Managing Committee from time to time.

7. **Replace the following in Article 15.ELECTION OF THE MEMBERS OF THE MANAGING COMMITTEE: a):**

*“All the fifty one (51) Members of the Managing Committee will be elected **and** co-opted for a period of three (3) years”*

instead of

*“All the fifty one (51) Members of the Managing Committee will be elected **or** co-opted for a period of three (3) years”*

8. **Add the following in Article 15. ELECTION OF THE MEMBERS OF THE MANAGING COMMITTEE: b):**

No one should be considered as a qualified candidate for any post of the Management Committee before being elected as a member after a minimum of 3 (three) years of life membership. Moreover, a minimum of 2 (two) years of service as a sub-committee member must be served.

9. **Add the following in Article-17 (c):**

All those members of the Management Committee whose monthly dues are in arrears for more than 6 (six) months will be requested to pay the arrears by issuing a 30 (thirty) day notice. In case of failure to pay the subscription, their membership can be canceled/nullified after discussion in the management committee meeting.

10. Add the following in Article -17 (d):

If for any reason the post of President, Secretary General, Treasurer becomes vacant, then on the basis of seniority the Vice President, Joint Secretary General and Joint Treasurer or from any member will be appointed to the vacant posts in the Management Committee meeting.

11. Replace the following in Article 25.THE DEPARTMENTAL SECRETARIES: b.

The Sub-Committees shall be replaced as follows-

i) *“Finance, Purchase &Sales and Audit Sub-Committee”*

instead of

“Finance Sub-Committee”

vi) *“Security and Asset Management Sub-Committee”*

instead of

“Security and Management Sub-Committee”

vii) *“Membership, Office & HRM Sub-Committee”*

instead of

“Office & HRM Sub-Committee”

12. Add the following in Article 26.RULES AND REGULATIONS:

“The Management Committee may frame rules and regulations for holding election of the Masjid Society and for the management and administration of the Masjid Society”

instead of

“The General Council may frame rules and regulations for holding election of the Masjid Society and for the management and administration of the Masjid Society”.

13. Add the following in Article 26. RULES AND REGULATIONS:

e. Election Rules and Regulations.

f. Purchase & Sales Rules and Regulations.
